| TICKET CENTRE FEE (includes set up, sales and tkt reports) | \$300 (per performance)  |
| COMP/CONSIGNMENT TICKETS                                   | Consignment tickets will be charged out at \$3.50 per ticket per performance.  |
| CREDIT CARD CHARGES  | 3% of credit card purchases.   |
| CAPITAL DEVELOPMENT CHARGE                                 | \$2 per ticket. 50 cents on tickets which are \$15 or less (to be included in advertised ticket price)   |

**Tariff 4B1** Classical Music: 1.56% of sales; **Tariff 11B** - Comedy & Magic Shows \$39.27
